

****The Stany Zjednoczone to Special FX + Two (2) Fee-Free Transaction Promotion****

- To be eligible for the Stany Zjednoczone to Special FX + Two (2) Fee-Free Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Stany Zjednoczone to during the Promotion Period (a "qualifying transfer").
