

****New Customer Send via WhatsApp Promotion Terms and Conditions****

- To be eligible you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (such successfully completed transfer is a “qualifying transfer”).

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered “successful” transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

0-Fee transfer conditions:

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

Special FX Rate conditions.

- The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer up to the promotion cap as stated in the table below (the “Promotion Cap”).
