

## **The Stany Zjednoczone to Honduras Fee-Free on First Transfer + Discount on Second Transfer Promotion**

### **Terms and Conditions:**

- To be eligible for the Stany Zjednoczone to Honduras Fee-Free on First Transfer + Discount on Second Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer from Stany Zjednoczone to Honduras during the Promotion Period (each a "qualifying transfer").
