

The Austrália to Índia Zero-fee Transaction Promotion

Terms and Conditions:

- To be eligible for the Austráliato ÍndiaZero-fee Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's zero-fee transaction-branded landing page and successfully complete your first transfer to Índia.
- The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.
- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Transfers submitted outside of the Promotion Period will not be eligible for a 0-fee transfer. Zero-fee transactions do not apply to transactions made with credit cards.
- A transfer is considered "Successfully Completed" when funds are deposited into your intended recipient's bank account [or the cash sent is picked up by the recipient at one of our partner locations].
- Your election to participate in the Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in the Promotion is final.
