

The India FX Boost + \$ Transfer Discount Promotion

Terms and Conditions:

- To be eligible for Canada to India FX Boost + \$ Transfer Discount Promotion ("Promotion") you must sign up for Remitly through Remitly's referral-branded landing page and successfully complete your first transfer to India (e.g., a "qualifying transfer").

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account; are picked up by your recipient at a cash pick-up location; properly delivered to the recipient and/or deposited into the recipient's mobile wallet (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer. This is a limited time offer.**

- **Transfer Discount & Special FX Rate Conditions.** Provided you have submitted a qualifying transfer on your first transaction, Remitly will automatically apply the \$ discount to and the Special FX Rate to that transfer.
