

## The Canadá to Ruanda Special FX + Discount Transfer Promotion

### Terms and Conditions:

- To be eligible for the Canadá to Ruanda Special FX + Discount Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer which must be from Canadá to Ruanda during the Promotion Period (a "qualifying transfer").
