

## **\*\*The Ilhas Maurício Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Ilhas Maurício Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Ilhas Maurício.

- Amounts sent in excess of the Promotion Cap will be sent at the FX Rate applicable to the service selected by you at the time of your transaction.
