

## **\*\*The Franța to Brazilia Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Franța to Brazilia Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Franța to Brazilia during the Promotion Period (a "qualifying transfer").
