### **Terms and Conditions:**

• To be eligible for the promotion ("Promotion") you must sign in via the screen which linked you to these terms and successfully complete a transfer to during the Promotion Period (a ""qualifying transfer"").

#### • 0 fee transfer(s) conditions.

• The 0 fee transfer will be directly applied to your first successfully completed transaction.

• 0 Fee transfer(s) do not apply to transactions made with credit cards.

### Transfer discount conditions.

• The transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer.

• Please note that your discount amount will not count towards the minimum spend requirements.

• The transfer discount cannot be used on subsequent transfers.
