

****The Filipino Special FX + 0 Fee Transfer Promotion****

****Terms and Conditions:****

- To be eligible for the Filipino Special FX + 0 Fee Transfer promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Filipino during the Promotion Period (the "qualifying transfer") .

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- **The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.]**

- The Promotion will entitle eligible customers to: (i) make one (1) transfer without transaction fees ; and (ii) make one (1) transfer of up to 1000 (the "Promotion Cap") to Filipino at the special foreign exchange rate (the "Special FX Rate") published on Remitly's Special FX branded landing page or mobile application that linked to these Terms and Conditions, as that rate was published at the time that the qualifying transfer is submitted by you.

- **0 Fee Transfer Conditions.** The 0 fee transfer will be directly applied to your first successfully completed transaction. 0 fee transfer(s) do not apply to transactions made with credit cards.

- **Special FX Rate Conditions.** The Special FX Rate will be applied by Remitly directly to your first qualifying transfer up to the Promotion Cap. If you send below the Promotion Cap, the Special FX rate will not be applied on subsequent transfers. Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of your transaction.

- All FX rates are subject to change from time to time at Remitly's discretion.

- This Promotion has no cash value and cannot be transferred.

- The "Promotion Period" begins on November 24th 2021 at 12:00:00 pm -0800 Pacific Standard Time and ends at 7:21:00 pm -0800 Pacific Standard Time on December 31st 2024. Remitly's server is the official clock for the Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving
