

## **\*\*The \$1000 to \$1000 Special FX + Two (2) 0-Fee Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the \$1000 to \$1000 Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from \$1000 to \$1000 during the Promotion Period (a "qualifying transfer").
- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be).
