

The Remitly to Remitly Zero-fee Transaction Promotion

Terms and Conditions:

- To be eligible for the Remitly to Remitly Zero-fee Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's zero-fee transaction-branded landing page and successfully complete your first transfer to Remitly.
- The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.
- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.
- The Promotion will entitle eligible customers to make one (1) transfer without transaction fees on their first transfer to Remitly (the "Qualifying Transfer").

Transfers submitted outside of the Promotion Period will not be eligible for a 0-fee transfer. Zero-fee transactions do not apply to transactions made with credit cards.
