

## **\*\*The Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from your Remitly account to your intended recipient's bank account or mobile wallet during the Promotion Period (a "qualifying transfer").

- 0 Fee transfer(s) do not apply to transactions made with credit cards.
