

****The ໄທໂຈໂຣ້ຍ Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the ໄທໂຈໂຣ້ຍ Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to ໄທໂຈໂຣ້ຍ.
