

### Terms and Conditions:

To be eligible for the **0 fee + special FX** first transfer (0 fee + special FX) second transfer (0 fee only) promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to **0 fee + special FX** during the promotion period (a "qualifying transfer").
