

Terms and Conditions:

To be eligible for the **0 Fee Transfer Conditions** to **Special FX Rate Conditions** first transfer (0 fee + special F) second transfer (0 fee only) promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to **Special FX Rate Conditions** during the promotion period (a "qualifying transfer").

For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be).
