


































The FX Boost + \$ Transfer Discount Promotion

Terms and Conditions:

- To be eligible for                            FX Boost + \$ Transfer Discount Promotion ("Promotion") you must sign up for Remitly through Remitly's referral-branded landing page and successfully complete your first transfer to       (e.g., a "qualifying transfer").
