

The Remitly Fee-Free on First Transfer + Discount on Second Transfer Promotion

Terms and Conditions:

- To be eligible for the Remitly Fee-Free on First Transfer + Discount on Second Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer from a Remitly account to a supported bank account during the Promotion Period (each a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **Fee-free transfer conditions.**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

- **Transfer discount conditions.**

- Once you have successfully completed your first qualifying transfer, The \$5 transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer when you send \$30 or more .

- Please note that your discount amount will not count towards any minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.

- This Promotion has no cash value and cannot be transferred.
