

## The Remitly App to Two (2) 0-Fees Transaction Promotion

### Terms and Conditions:

- To be eligible for the Remitly App to Two (2) 0-Fees Transaction promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to a U.S. bank during the Promotion Period ((a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **0 fee transfer) conditions.** The 0-fee transfer will be directly applied to your first two (2) successfully completed transactions. 0 Fee transfer(s) do not apply to transactions made with credit cards.

- This Promotion has no cash value and cannot be transferred.

- The "Promotion Period" begins on 01/13/2025 at 3:00 PM PST and ends at 3:59 PM PST on 01/31/2025. Remitly's server is the official clock for the Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion (acting reasonably).
