

The 0-fee on First Transfer + Discount on Second Transfer Promotion

Terms and Conditions:

- To be eligible for the 0-fee on First Transfer + Discount on Second Transfer promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (each such successfully completed transfer is a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **Fee-free transfer conditions.**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

- **Transfer discount conditions.**

- After you've successfully completed your first qualifying transfer, the transfer discount will be applied by Remitly to your next qualifying transfer and will be available only to that transfer if it meets any required minimum spend requirement as described on the screen which linked you to these terms and if it is successfully completed during the Promotion Period.

- Please note that your discount amount will not count towards any minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.

- This Promotion has no cash value and cannot be transferred.

- The Promotion begins on April 30, 2025 at 12:00 AM Pacific Standard Time and ends at 11:59 PM Pacific Standard Time on May 31, 2025 ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations,
