

The New Customer Transfer Discount Offer Code Promotion

Terms and Conditions:

- To be eligible for the New Customer Transfer Discount Offer Code promotion ("Promotion") you must redeem the respective transfer discount offer code via the notification that linked you to these terms or enter the respective transfer discount offer code at the "Redeem Offer" page when signed in to your Remitly account and successfully complete your first transfer during the respective Promotion Period as more fully described in the transfer discount offer code messaging that linked you to these terms (such successfully completed transfer is a "qualifying transfer").

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion.

- The Promotion Period for a respective transfer discount offer code begins and ends on the dates/times as more fully described in the transfer discount offer code messaging that linked you to these terms (each respective promotion period is a "Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the respective Promotion Period will not be eligible for this Promotion.

- Transfer Discount Offer Code Conditions. After you redeem a transfer discount offer code for this Promotion, the respective transfer discount will be applied by Remitly to your qualifying transfer if it is successfully completed during the respective Promotion Period. Please note that your discount amount will not count towards the minimum spend requirements. The transfer discount cannot be used on subsequent transfers.

- The Promotion and any respective transfer discount has no cash value and cannot be transferred.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive.
