

****The Fildişi Sahili Cumhuriyeti Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the Fildişi Sahili Cumhuriyeti Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Fildişi Sahili Cumhuriyeti.
