

****The Amerika Birleşik Devletleri to Şili Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the Amerika Birleşik Devletleri to Şili Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to the Şili (a "qualifying transfer").

- The Promotion is available for first time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion. This Promotion is not valid with any other offer.

- Special FX Rate Conditions. The Special FX Rate will be applied by Remitly directly to your first qualifying transfer up to the Promotion Cap. Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of your transaction.
