****Terms and Conditions:****

- To be eligible for the Amerika Birleşik Devletleri to Dominik Cumhuriyeti Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to the Dominik Cumhuriyeti (a "qualifying transfer").
