****Terms and Conditions:****

- To be eligible for the Amerika Birleşik Devletleri to Jamaica Special FX + Two (2) Fee-Free Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to the Jamaica (a "qualifying transfer").
