

## The Ấn Độ FX Boost + \$ Transfer Discount Promotion

### Terms and Conditions:

- To be eligible for Canada to Ấn Độ FX Boost + \$ Transfer Discount Promotion ("Promotion") you must sign up for Remitly through Remitly's referral-branded landing page and successfully complete your first transfer to Ấn Độ (e.g., a "qualifying transfer").

Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.
