

****The Canada to Việt Nam Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the Canada to Việt Nam Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Canada to Việt Nam during the Promotion Period (a "qualifying transfer").
