

****The Vương quốc Anh to Special FX + Two (2) Fee-Free Transaction Promotion****

- To be eligible for the Vương quốc Anh to Special FX + Two (2) Fee-Free Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Vương quốc Anh to during the Promotion Period (a "qualifying transfer").
