

Terms and Conditions:

To be eligible for the Vương quốc Anh to Philippines first transfer (0 fee + special FX) and second transfer (0 fee only) promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to Philippines during the promotion period (a "qualifying transfer").

For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be).
