

## **\*\*The Ý to Ấn Độ Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Ý to Ấn Độ Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Ý to Ấn Độ during the Promotion Period (a "qualifying transfer").
