

****The Cộng hoà Dominica Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the Cộng hoà Dominica Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Cộng hoà Dominica.

If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.
