****Terms and Conditions:****

- To be eligible for the Mỹ to Ấn Độ Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to the Ấn Độ (a "qualifying transfer").

- Special FX Rate Conditions. The Special FX Rate will be applied by Remitly directly to your first qualifying transfer up to the Promotion Cap.
