

## **\*\*The 阿拉伯联合酋长国 to 菲律宾 Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 阿拉伯联合酋长国 to 菲律宾 Special FX + Two (2) 0-Fees Transaction promotion ( “Promotion” ) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 阿拉伯联合酋长国 to 菲律宾 during the Promotion Period (a “qualifying transfer” ).
