

The 布隆迪 Special FX Promotion

Terms and Conditions:

- To be eligible for 布隆迪 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 布隆迪.
