

****The 澳大利亚 to 哥伦比亚 Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the 澳大利亚 to 哥伦比亚 Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 澳大利亚 to 哥伦比亚 during the Promotion Period (a “qualifying transfer”).
