

The 澳大利亚 to 印度 Zero-fee Transaction Promotion

Terms and Conditions:

- To be eligible for the 澳大利亚to 印度Zero-fee Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's zero-fee transaction-branded landing page and successfully complete your first transfer to 印度.
- The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.
- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion.
