

## The 纳米比亚 Special FX Promotion

### Terms and Conditions:

- To be eligible for 纳米比亚 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 纳米比亚.
