

****The 加拿大 to 墨西哥 Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the 加拿大 to 墨西哥 Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 加拿大 to 墨西哥 during the Promotion Period (a “qualifying transfer”).
