

The New Customer Transfer Discount Offer Code Promotion

Terms and Conditions:

After you redeem a transfer discount offer code for this Promotion, the respective transfer discount will be applied by Remitly to your qualifying transfer if it is successfully completed during the respective Promotion Period. Please note that your discount amount will not count towards the minimum spend requirements. The transfer discount cannot be used on subsequent transfers.

and cannot be transferred.
