

## **\*\*The 刚果 布拉柴维尔 Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 刚果 布拉柴维尔 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 刚果 布拉柴维尔.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.
