

## **\*\*The 意大利 to 印度 Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

• To be eligible for the 意大利 to 印度 Special FX + Two (2) 0-Fees Transaction promotion ( “Promotion” ) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 意大利 to 印度 during the Promotion Period (a “qualifying transfer” ).
