

****The 多米尼加共和国 Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the 多米尼加共和国 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 多米尼加共和国.
