

## **\*\*The 新西兰 to 印度 Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 新西兰 to 印度 Special FX + Two (2) 0-Fees Transaction promotion ( “Promotion” ) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 新西兰 to 印度 during the Promotion Period (a “qualifying transfer” ).

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). - 0 Fee transfer(s) do not apply to transactions made with credit cards.
