

****The 新西兰 to 菲律宾 Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the 新西兰 to 菲律宾 Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 新西兰 to 菲律宾 during the Promotion Period (a “qualifying transfer”).
