****Terms and Conditions:****

- To be eligible for the 西班牙 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 西班牙.

- Amounts sent in excess of the Promotion Cap will be sent at the FX Rate applicable to the service selected by you at the time of your transaction.
